Bloomington North Rotary Organizational Membership

Key Elements:

• What is an "Organizational Member"? An Organizational Membership is for any type of organization and consists of at least one Primary Member and up to 2 additional Designee Members. Each of these members should be leaders in the organization.

• Flexibility. At least one Primary Member is responsible for sending one of the Designee Members to club meetings when the Primary Member is unable to attend. Of course Designee Members are also welcome to attend when a Primary Member attends.

• **Application:** Both the Primary Member and the Organization are evaluated by the membership committee and must be approved by the Club's board of directors.

Organizational Membership Costs:

- Initiation Fee: \$140 One Time
- International Rotary Dues: \$276 Annual for each Primary Member (can be billed quarterly at \$69/quarter)

• **Club Rotary Dues:** \$100 Annual for each Primary Member (can be billed quarterly at \$25/quarter)

- Club Meals: pay for your own when you attend.
- **Sustaining Membership:** \$100 suggested annual donation to The Rotary Foundation of Rotary International is encouraged. (Will apply towards a Paul Harris Fellowship for each Primary Member.)

At any time if a Designee Member would like to be an additional Primary Member you can pay the additional International Rotary Dues for the additional Primary Member and optionally the Sustaining Membership. Club Meals will be bill the same based upon attendance and a minimum of one meal per week for the organization not for each primary member.
